## Mother-Daughter Celebrate First PSI Anniversary

Brandy Boros-Hairston, the daughter of the team, has been with PSI for five years. She works as a Psychologist at two schools: Hope Academy in Cleveland and the Academy of St. Bartholomew West in Middleburg Heights. Brandy's duties consist of testing, individual and group counseling, and IAT (Intervention Assistance Team) meetings.

"I really love working with the kids," Brandy says. "It's gratifying to build relationships, gain their trust and be able to make a difference." What is challenging, she adds, is that school is only one part of their day. There are other influences such as family, which alone can be fluid and changing, the neighborhood, the media and more. "The students are at an age where there is room and I can help them grow."

It was through Brandy that her mother Mary Boros-Hairston, known as Butchie to friends, joined PSI as an RN a year ago.

Butchie works at three schools: St. Anthony of Padua and St. Peter Elementary School, both in Lorraine, and St. Joseph's Elementary School in Amherst.

Butchie brings 38 years of experience as a practicing RN, 15 of them in ER! With PSI, for the most part, it's treating minor cuts, bumps and bruises after recess and gym. "The favorite item in the clinic is the ice pack. The kids think it will take care of everything."

Butchie adds: "As the school RN, I have to create relationships with families and students within a heartbeat. It's a great feeling when the kids greet me with, 'Hi, how are you doing.' That tells me a lot."

Both greatly enjoy working at PSI and hope this first year anniversary lead to many more.

## *From the Desk of* Karen McKelvey, Prevention/Intervention & Special Projects

### PREVENTION/INTERVENTION

Prevention/Intervention programs will begin the week of September 14, 2009. There have been some exciting updates in the Cyber-Bullying and Trash Talking program to include topics such as sexting and responsible cell-phone usage. The Successful Teen Living program now includes an option for schools to utilize selected juniors as mentors for working with the freshman class on such topics as decision-making, tobacco use prevention, alcohol and drug use and abuse, and healthy teen relationships.

All PSI schools that chose PSI as their Prevention/Intervention service provider for the 2009-2010 school year will receive an additional grant choice in the areas of Health/Wellness, Educational Specialist, School Psychology, Professional Development, School Marketing or an additional Prevention program. This grant program reinforces the "Team PSI" approach to offer the best possible services to our partner schools by combining the strengths of our many disciplines and talented staff.

### SPECIAL PROJECTS

The *PSI in the A.M.* breakfast series is scheduled to begin September 23, 2009 with a presentation on preparing for H1N1 Flu. Speakers will present in conjunction with PSI Health Managers as part of our on-going health education series. Included will be Bruce Hennes who will address crisis communication and Ann Gynn, Executive Director, Business Emergency Planning Institute to address what to expect during a flu pandemic, the differences between seasonal and pandemic flu, how influenza virus spreads, and the steps to reduce contagion in your school.

On October 28, 2009, Kathy McNamara, Ph.D. of Cleveland State University will speak on conducting successful Parent Conferences. This seminar will describe effective tools and tips for conferencing and will also provide methods to deal with challenging parents and issues.

PSI's LanguageCultureConnection services continue to expand. With ChinaLink in its third year, Mandarin language teachers are now working in additional elementary schools as well as teaching Mandarin 1 and 2 in high schools. PSI now has a unique Mandarin language curriculum for a program that truly sets schools and students apart.

PSI is also placing Spanish Language teachers at the request of some of our partner schools. Principals are utilizing this service in creative ways by offering Spanish instruction to several grade levels, or if funding is an issue, they are offering 9-week units to selected grade levels to maximize the school's financial resources.

Please check to see if your school has a new or returning Mandarin or Spanish language teacher and introduce yourself as a fellow PSI employee! Also, look for the new LanguageCultureConnection Newsletter that will be published periodically this school year.



### House Bill 276-House Bill 1

This is a reminder that all PSI professionals must complete the HB 276-HB 1 Safety and Violence Prevention Training (which now extends the training requirement to middle and high school personnel) within two years of their employment and must send documentation of same to Patty Wey at the PSI office. If you were employed by PSI prior to the 2008-2009 school year, you should have completed the training by March 30, 2009.

The child abuse law, that mandated at least four hours of education on various aspects of child abuse, has been expanded to include nurses who work in middle and high schools as well as elementary ones. If you are a PSI nurse working in any school, this training is now required. Please contact the office for information about how to obtain

the training, if this new law applies to you. Letters have been mailed to personnel affected by this ruling.

The H1N1 flu was just starting to affect individuals in the U.S. as most schools were concluding last school year. The newest guidelines on dealing with the virus may be found on the ODH website and can be accessed online. We encourage all staff to be familiar with the guidelines, as it is predicted that the flu may strike quite virulently when school resumes. Along these lines, new Health Resource Guide updates will be out shortly, either via mail or at the Fall Meeting. These two excellent web sites contain valuable information about the H1N1 virus and the steps we need to take in the schools as health professionals.
