TITLE I

Title I, Part A (generally known as Title I) was established by the Elementary and Secondary Education Act (ESEA) and amended in the Every Student Succeeds Act (ESSA).

What is Title I

Title I funds programs for students from low-income families, focusing on helping these learners meet rigorous and relevant state academic standards.

The federal government allocates Title I funds to State Education Agencies (SEAs) using formulas mainly based on census data. The specific amount of Title I funding allocated to your state and district can be found on the Department of Education's website under the ESEA Title I LEA Allocations page.



School Wide Programs

Schools can utilize funding resources flexibly in order to serve the entire student body.



Targeted Assistance Program

Schools use funding resources to assist specific students who are identified as academically failing or at risk of failing.

TITLE II

Title II, Part A is a U.S. Department of Education grant program that provides supplemental funding to help support effective instruction.

What is Title II

Title II aims to enhance student academic performance by backing initiatives that elevate the quality of teachers and principals. It seeks to boost the presence of highly qualified teachers in classrooms and ensure that schools have highly competent principals and assistant principals.

The U.S. Department of Education awards Title II, Part A funds to state educational agencies (SEAs), which then subgrant funds to LEAs.



Quality and Effectiveness

Improve the quantity, quality and effectiveness of teachers, principals and other school leaders; who are effective in improving student academic achievement in schools; and



Student Achievement

Increase student achievement consistent with state standards;



Hire and Retain

Hire and retain effective teachers to improve the equitable distribution of teachers, particularly in low-income schools with high percentages of ineffective teachers and high percentages of students who do not meet state standards.

TITLE III

Language Instruction for English Learners and Immigrant Children and Youth Subgrants

What is Title III

Title III aims to help English Learners (ELs) achieve proficiency in English by providing targeted instruction for ELs and recent immigrants. It also includes support for teachers and educational staff, family engagement initiatives, and the acquisition of resources to enhance EL instruction and programs for immigrant children and youth.



Quality and Effectiveness

Title III funds are strict and students must qualify as ELs and immigrant students under a specific definition in order to receive funds.



Student Achievement

Programs funded by Title III must directly benefit ELL students; the programs/materials cannot be used in other classrooms with non-EL learners.

TITLE IV

Title 4 is the newest of the title funds and was passed in the Every Student Succeeds Act (ESSA) of 2015.

What is Title IV

The funding prioritizes three key areas: (1) promoting a well-rounded education with advanced classes, fine arts, foreign languages, and STEAM programs; (2) fostering safe, healthy schools through social-emotional learning and healthy habits; and (3) enhancing technology use by training staff and delivering quality digital learning for underserved students.



Quality and Effectiveness

Improve the quantity, quality and effectiveness of teachers, principals and other school leaders; who are effective in improving student academic achievement in schools; and



Student Achievement

Title IV programs greatly benefit students. A 2020 DOE report shows that states used these funds to enhance professional development in educational technology (33 states) and improve tech infrastructure (30 states), highlighting a strong focus on STEM education.

EANS

There are two allocations for the EANS program:

What is EANS I

The purpose of the EANS program is to provide services or assistance to eligible nonpublic schools to address the impact that the Coronavirus Disease 2019 (COVID-19) has had, and continues to have, on nonpublic school students and teachers in the state.

What is EANS II

GEER EANS II is a continuation of the support established under CRRSA to provide services or assistance to non-public schools that enroll a significant percentage of low-income students and are most significantly impacted by the coronavirus emergency.



How Can EANS funds be used?

- Enhancing existing technology
- Develop and implement curricula or programs that promote student success
- Training and professional development for staff
- Providing support services to students, such as mental health, counseling or transportation.
- Purchasing supplies and materials (textbooks, computers, software)
- Hiring additional staff
- Purchasing/leasing school buildings or equipment to accommodate special needs students.
- Establishing scholarships and grants for students

IDEA

IDEA (Individuals with Disabilities Education Act).

What is IDEA

IDEA was originally enacted by Congress in 1975 to ensure that children with disabilities have the opportunity to receive a free appropriate public education, just like other children.



Effectiveness

By providing tailored support and resources, IDEA has significantly improved access to education for millions of students, helping them achieve academic success alongside their peers.



Student Achievement

The primary goal is to ensure that students with disabilities have the same educational opportunities as those without disabilities. IDEA does the following for all children with an identified disability:

- Receives special education to address their individual needs.
- Be prepared for employment and independent living.
- Ensures rights of children with disabilities and their families be protected under the law.
- Assesses and ensures the efforts of institutions providing services to persons with disabilities.
- Assists states, localities, and agencies in educating children with disabilities.
